Panorama of Possibilities: Queens

Project Description

This summer the IPA will locate our Residency in Queens, the largest and most diverse borough in New York City. Across this mixed-income borough the pressures of new development are changing the affordability and character of many of its vital neighborhoods. Given the dramatic rezoning and subsequent building boom in Long Island City, the proposed rezoning of Willets Point, and the constant building proposals brought to community boards across the borough, the IPA aspires to democratize the conversation and engage the Queens citizenry, institutions and stakeholders around future development. Specifically, our Fellows will utilize and make accessible community district data, as-of-right zoning, and other relevant mapping research for the neighborhoods surrounding Flushing Meadow Park. Using this information, combined with the leveraging of under-utilized neighborhood assets and untapped spatial opportunities, the Fellows will work with community members to create innovative and appropriately scaled design responses.

Through the IPA's collaboration with the Queens Museum, our Fellows will have direct access to the invaluable urban planning resource of The Panorama of the City of New York, a 1"-100' scale model of all five boroughs originally conceived for the 1964 World's Fair by 'master builder' Robert Moses. The 'City of Promise' will serve as the backdrop to the cohorts' research and design work, to visualize development opportunities, either through 3D graphic imagery or actual scaled building models, that will address community aspirations, strengthen public interaction, and more fully reflect the diversity and vitality of its residents.

About the Fellowship

Below is a description of the 2018 Fellows Residency Program:

The Fellowship: Up to eight selected Fellows will work in Queens utilizing publicly obtained as-of-right development information to visualize design opportunities in the borough. To assist in this endeavor the IPA has engaged Michael Kwartler, the founder of the Environmental Simulation Center, a non-profit created to use information technology for performance-based planning, design and decision-making. Through research and collaboration with City officials, the Fellows are asked not only to develop their individual project but are encouraged to collaborate with each other. To facilitate the collaboration, the IPA will enable the cohort to:

- Meet weekly with guest lecturers
- Share team meals
- Collectively problem solve

The Residency lasts eight weeks. By providing an intimate setting for our cohort of Fellows with outside practitioners and stakeholders, the IPA provides a rich educational experience. The summer residency will culminate with a public exhibition of the projects, to be augmented with Fellow presentations, panel discussions, screenings and public forums.

Selection

Selection criteria: Innovative contribution to discourse on housing, sanctuary cities, and engagement with community. (We are accepting proposals with a range of experience.)

Benefits & Expectations

Fellows will be given space to exhibit their work and to foster collaboration. During the residency, we will facilitate connections with local nonprofits and advocacy groups and will bring in experts to critique the Fellows' work. A small stipend will be provided. Fellows will present their work-in-progress publicly and in a culminating open studio reception.

Fellows receive:

- Recognition as Institute for Public Architecture Fellows.
- Space for exhibition and collaboration for two months.
- Access to community groups, experts in design, architecture, planning and policy.
- IPA will facilitate events and open studio.
- Promotion through IPA campaigns.
